# PCSP 39/22 Update from Designated Members

#### **NIFRS**

Mickey Curran (NIFRS) updated the Members on the impact of the rollout of the P5 Fire Safety Video. He relayed an incident where two children travelling in the car with their grandmother and noticed the smell of smoke and raised the alarm telling the grandmother to pull over and exit the vehicle. This quick thinking can be attributed to the fire safety message they heard at a session in Kesh Primary School. The NIFRS and PCSP has organised a recognition at the Fire Station to take place later in the week to be attended by the PCSP Chair and Vice Chair. The Members commented on the actions of the children and the benefit of education and awareness raising work in primary schools.

#### **PSNI**

Insp Fallis (PSNI) thanked the PCSP for the financial assistance towards the Youth on Water project. The project, delivered by the PSNI and Blue Green Yonder, worked with 4 groups of young people over 5 weeks delivering water-based activities and promoting engagement with Neighbourhood Policing Teams. At the end of project celebration held participants were presented with completion certificates and enjoyed an afternoon of water activities with their families.

# Youth Justice Agency

Sinead Dolan (YJA) informed the meeting that the 2021-2022 Performance Impact would be released shortly and encouraged Members to read and give feedback as appropriate.

#### PCSP 40/22 PCSP Activity Report July - September 2022

The PCSP Manager gave a presentation on PCSP activity for the period July–September 2022. Highlights include The Ambassadors Programme,

County Shows, New Driver NI Launch, Tackling Violence Against Women and Girls Launch Event, Ballinamallard Youth Soccer Event, and visits to community groups promoting engagement with Neighbourhood Policing Teams and relating community safety messages.

Sandra Armstrong (Project Officer) gave a short presentation on the Safer at Home and Vulnerability Project giving examples of equipment provided and case studies of types of visits being carried out and onward referrals process for assistance from other agencies and services.

The Members commented on the variety and amount of work delivered and asked that their thanks are conveyed to the PCSP staff team for their hard work and commitment to the delivery of the Action Plan. Cllr Deehan informed the Members of the Herbert Protocol for people with dementia at risk of going missing.
